- Released new Strategic Plan with updated objectives for 2023-2026
- Released new Income and Benefits Survey results available to view by Corporate Members
- [Influenza Vaccination Remuneration Increased.](#) Pharmacists Manitoba along with the help of EAC negotiated an increase to remuneration to \$8.00 plus a \$5.00 administration fee per shot for total compensation of \$13.00 per shot.
- In August, our negotiations resulted in an [increase to the maximum NIHB dispensing fee to \\$15.22](#) from the previous cap of \$14.86.
