Indigenous-led and Determined Pharmacy Practice Evolution MCKESSON

Canada

This session will introduce attendees to the Indigenous Pharmacy Professionals of Canada (IPPC), an association representing Indigenous pharmacists, pharmacy technicians and pharmacy assistants with proof of Indigenous ancestry. IPPC's purpose and initiatives will be introduced, including reviewing cultural competencies in addressing Indigenous health inequity. Learners will be invited to review the recommendations and rationale from Indigenous communities regarding Indigenous representation in healthcare, and understand the definition, and practice collaboration strategies, of Indigenous-led and determined perspectives. Finally, attendees will be introduced to the purpose, role, and immeasurable value that Indigenous Knowledge Keepers and Elders perform in the health and wellbeing of Indigenous communities & as advisors to non-Indigenous organizations & institutions.

Learning Objectives

- Become familiar with the Indigenous Pharmacy Professionals of Canada, its purpose, and initiatives, and describe the importance of the organization's role as a collaborator with pharmacy stakeholders in truth and reconciliation efforts
- Describe the importance of Indigenous perspectives and cultural competencies in bridging health inequities for Indigenous Peoples
- Define "Indigenous-led and determined" and describe the importance of this element in studying and implementing Indigenous health interventions
- Detail 2 strategies to integrate Indigenous-led and determined perspectives into practice
- Introduce the role that Indigenous Knowledge Keepers play in Indigenous communities, Indigenous health, and as advisors to non-Indigenous organizations and institutions

Amy Lamb, BSP, Executive Director, Indigenous Pharmacy Professionals of Canada Amy Lamb is the Executive Director of the Indigenous Pharmacy Professionals of Canada and she represents IPPC as a member of the Indigenous Guiding Circle for the Canadian Medical Association, the FNHIB Anti-Indigenous Racism Advisory Circle, the Indigenous Healthcare Organization Collective and CPhA's Workplace Wellness Task Force.

Amy has been a community pharmacist since 2012, and currently serves as the Director of Northern Health for WillowGrove Pharmacy in her hometown of Prince Albert, Saskatchewan, where she supports the pharmacy's supply and support to remote Indigenous communities. Amy's role includes travel to Indigenous communities, providing clinical and primary care support to health teams, as well as attending and contributing to community events.

KEYNOTE: Disruption is Coming: If you're not at the table, you're on the menu

A look at the biggest changes coming to pharmacy and how we need to prepare

Jim will interpret what pharmacy professionals and owners can expect when the widespread scope and reimbursement changes that have been sweeping the world and across Canada, inevitably come to Manitoba, and then explore the collision of three powerfully disruptive forces in 2024: the growing primary care crisis, national pharmacare and the existential threat of US-style insurance & preferred networks. He will suggest who will be working in pharmacies over the next five years, where our money will come from, and describe the most important single factor influencing patient outcomes, professional job satisfaction and the financial viability of every pharmacy in the world. And he'll give a sneak preview of his 9:55 session on where the heck we will find the time to deal with all of this change!

Jim Danahy, Co-Founder, AdhereRx

Jim Danahy has been designing workflow and profit improvement processes for pharmacies for 25 years. A second-generation pharmacy owner originally from Ontario, Jim has worked with pharmacies in every province and territory, and been a co-owner of Howe Sound Pharmacy in BC and an independent pharmacy/specialty IV infusion clinic in New Brunswick. He makes his home in Saint John NB. In 2013, Jim partnered with Chris Juozaitis of Howe Sound Pharmacy in Gibsons BC, and a group of colleagues to form a firm called AdhereRx. The group began to measure and codify how Howe Sound Pharmacy's new pharmacist-at-intake workflow was generating remarkable results. The team turned the insights into support programs and a professional training curriculum; some have called the process "Moneyball for pharmacy". In 2016 AdhereRx acquired 50% of Howe Sound Pharmacy. AdhereRx collaborates with universities, industry organizations and advises professionals. Jim continues to enjoy a 9-year relationship as a keynote speaker and advisor to the industry associations, academics and pharmacy regulators. He was the founding Director of The Centre of Excellence in Retail Leadership in the Schulich Executive Education

Jennifer is currently in a term position with the Practice Development Team for the WRHA Regional Pharmacy program and maintains a clinical practice in the ambulatory chronic kidney disease clinic at HSC.


